COOKIE CLARIFICATION TEXT

1. GENERAL INFORMATION ON COOKIES

This clarification text covers the web sites managed by Emas Demir Celik San. ve Dis Tic. Ltd. Sti., and it contains explanations about the use of cookies. You consent to the use of cookies in the manner specified in this clarification text by using our site.

1.1. What is Cookie?

Cookies are small text files that are stored on the visitor's device (e.g., computer or phone) when a website is visited, and they can contain data in the name-value format. The text files in question can be interpreted by browsers and servers that can access them, and by this way, various information about the device on which the website is visited and therefore the relevant user can be obtained. Today, almost every website uses cookies.

1.2. For what purposes are the cookies used?

Cookies are used for many different purposes. For instance, cookies are used for the following purposes:

- o The website works properly (For instance; displaying content such as text, photographs, links in the site in the right places)

- o Developing and optimizing the website (For instance; taking the pages with errors or not preferred to an operational status) and
- o Remembering the preferences of visitors (For instance; the information you enter while logging into our website, language preference, and other preferences)
